Applications are invited On-line through APSPDCL Website <http://apspdcl.cgg.gov.in> from 28.08.2014 to 27.09.2014 from eligible candidates for filling up the following vacancies on regular basis in APSPDCL.

The Desirous eligible Candidates may apply On-line by satisfying themselves with the terms and conditions of this recruitment.

The vacancies will be filled with the spirit of presidential order.

RESERVATION TO LOCAL CANDIDATES:

Reservation to the local candidates is applicable as provided in the Rules and as amended from time to time in force on the date of notification. The candidates claiming reservation as Local candidates should obtain the required Study certificates from Class IV to X or Residence Certificate in the proforma only for those candidates who have not studied in any Educational Institutions as the case may be. The relevant certificates may be got ready with authorised signature and kept with the candidates as and when required.

The Government of A.P. has issued orders for transfer of Ananthapur & Kurnool Districts from erstwhile APCPDCL to APSPDCL under the provisions of AP reorganization act 2014. Now the APSPDCL jurisdiction consists of Eight districts (Viz. Krishna, Guntur, Prakasam, Nellore, Chittoor Kadapa, Anantapuram, Kurnool) shall be declared as the local area for localizing the Assistant Engineer cadre in Engineering Service for the purpose of recruitment for following the spirit of Presidential Order.

The following percentage of reservation of posts in respect of local candidates shall be followed while making direct recruitment in APSPDCL for following the spirit of Presidential Order.

“70% of the posts are to be filled by Direct Recruitment shall be reserved for local candidates in respect of Assistant Engineer in Engineering Service, APSPDCL as unit which was declared as local area for the said post. The remaining 30% of the posts shall be filled by open competition wherein local and non local candidates can compete.”

DEFINITION OF LOCAL CANDIDATE:

“LOCAL CANDIDATE” means a candidate for direct recruitment to any post shall be regarded as a local candidate in relation to a local area on the following conditions:-

- (i) Who has studied for the maximum period out of seven years immediately preceding the passing of the qualifying examination or Xth class whichever is lower in the concerned local area i.e., the jurisdiction of APSPDCL consists of Eight districts (Viz. Krishna, Guntur, Prakasam, Nellore, Chittoor Kadapa, Anantapuram, Kurnool)
- (ii) Where the periods of his/her residence is in two or more local areas & if they are equal such local area where he has resided last in such equal periods will be considered.
- (iii) In cases where visually handicapped and hearing handicapped persons studied in the special schools meant for them, the native place of the parents of such visually handicapped and hearing handicapped persons will be the local area.

NOTE:

- A. Study certificate from IV to X class would suffice for enabling the candidate to apply as a **“LOCAL CANDIDATE”**
- B. Residence Certificate in prescribed proforma only for those candidates who have not studied in any educational institutions as the case may be will be accepted.

- O- Open Competition Vacancies (Local/Non Local candidates can compete),

L- Vacancies reserved for local candidates only.

In view of AP reorganization Act 2014, the state of residual AP is consisting of 13 Districts only w.e.f. 02.06.2014. The candidates belonging to states other than A.P. will be considered as General Category only i.e., OC category irrespective of their caste.

These vacancies are subject to variation at the time of recruitment based on the necessity.

Fee:

i) Each applicant must pay Rs.150/- (Rupees One hundred and fifty Only) towards Application Processing Fee.

ii) Applicants under General category must also pay **Rs.350/- (Rs. Three hundred and fifty only)** towards Examination Fee in addition to Rs.150/-

Note: Applicants belonging to SC/ST/BC Communities and PH need not pay Rs.350/-

- iii) Candidates belonging to States other than Andhra Pradesh will be considered in general category only and required to pay the above prescribed fee of Rs.350/- (Rs.Three Hundred and fifty Only) in addition to Rs.150/-.

I. Instructions for Scanning of Photograph with Signature

1. Paste the photo on any white paper as per the above required dimensions. Sign in the Signature Space provided. Ensure that the signature is within the box.
2. Scan the above required size containing photograph and signature. Please do not scan the complete page.
3. The entire image (of size 3.5 cm by 6.0 cm) consisting of the photo along with the signature is required to be scanned and stored in *.jpg format on local machine.
4. Ensure that the size of the scanned image is not more than 50KB
5. If the size of the file is more than 50KB, then adjust the settings of the scanner such as the dpi resolution, no. of colours etc., during the process of scanning.
6. The candidate has to sign in full in the box provided. Since the signature is proof of identity, it must be genuine and in full; initials are not sufficient. Signature in CAPITAL LETTERS is not permitted.
7. The Signature must be signed only by the candidate and not by any other person.
8. The Signature will be used to put on the Hall Ticket and wherever necessary. If the candidate's signature on the answer script, at the time of the examination, does not match the signature on the Hall Ticket, the candidate will be disqualified.

II. ELIGIBILITY:

1. AGE:

- Age not below 18 years and not more than 34 years for OC candidates as on date of Notification Upper age limit will be relaxed up to 5 years in respect of SC/ST/BC candidates and up to 10 years in respect of P.H candidates.

2. EDUCATIONAL QUALIFICATION

Must possess B.E/B.TECH/A.M.I.E. in Electrical & Electronics Engineering or equivalent qualification in the similar discipline from any recognized University in India under regular basis.

The degree awarded by the Universities/institutions that are recognized by the U.G.C, D.E.C (Under IGNOU) and AICTE as the case shall only be considered.

The qualifications acquired from universities/Institutions through Distance Mode will not be considered as per Circular.Memo.No.Addl.Secy/DS(L,IR&R)/AS(L,IR&R)/PO(Regulation)/ JPO-1/468/12, Dt.13.09.2013 which can be accessed in Website along with Notification.

Note: If there is any deviation from the above qualification for the above post, the candidates shall produce the equivalency certificate from the authority issuing the qualification certificate viz Registrar of the University or Secretary of the Institute for accepting his/her application.

III. SELECTION PROCEDURE:

The Selection of candidates for appointment as Assistant Engineers/El will be as follows:

- i) The selection of candidates for appointment will be made 100% on written examination.
- ii) Selection shall be made duly following the Rule of Reservation for SC, ST, BC & Physically Handicapped, and as per the **Presidential Order**.
- iii) Only those candidates who qualify in the written examination by being ranked high, community wise will be called for verification of Original Certificates in 1:1 ratio.
- iv) The Minimum qualifying marks in the written test for the above selection process shall be as follows:

OC	-	40%
BC	-	35%
SC/ST	-	30%
PH	-	30%

Note: Mere securing minimum qualifying marks doesn't vest, any right to a candidate for being called for verification of original certificates.

IV. Details of Written Examination:

- i) **Syllabus:** The Syllabus for the written examination is placed at Annexure.
- ii) **Hall Tickets:** The hall tickets will be placed on the Website seven days prior to the date of examination. The Candidate has to download the Hall ticket from the website only. Hall tickets will not be sent to the candidates by post.

V. TERMS AND CONDITIONS OF SERVICE:

1. **Scale of Pay:** Rs. 23115-955-25025-1115-30600-1280-35720
2. **Training:** The candidates appointed to the post shall be placed on Training cum Probation for a period of 2 Years.

3. **Place of posting:** The candidates appointed shall be required to work at Rural operation sections any where in SPDCL..
4. The Candidate will be governed by the rules and regulations applicable or as framed by the APSPDCL and as amended from Time to time. The Tripartite Agreement entered into Between the APSEB, Government of A.P and the Employees Associations is not applicable to these candidates and they shall at no stage be entitled to claim any right what so-ever arising out of the said Tripartite Agreement.

VI. Execution of Bond:

- (i) The candidates so appointed will be required to execute a Bond (in Non-Judicial stamp paper worth Rs.110/- (Rupees One hundred and ten only) at the time of joining, to serve APSPDCL for a Minimum period of 5 years after completion of Training –Cum-Probation period (2 years).
- (ii) During the above bond period the candidates will deposit their original certificates such as Degree, date of birth and community, etc with APSPDCL. The Certificates so deposited with APSPDCL shall not be returned until the completion of bond period.
- (iii) If the candidates desire to take back their original certificates during the above bond period they have to pay an amount of Rs.60000/- towards deposit amount which will be refundable after re-submission of original certificates.
- (iv) The candidate who leaves the APSPDCL service during the Training-Cum-Probation period shall refund the emoluments received by him/her plus Rs. 30,000/- (Rupees Thirty thousand only) by way of liquidated damages.
- (v) The candidate who leaves the APSPDCL service without serving a minimum period of 5 years after completion of Training-Cum-Probation period shall have to pay a sum of Rs.60,000/- (Rupees Sixty thousand only) by way of liquidated damages to the Corporation.

VII.HOW TO APPLY:

HOW TO UPLOAD THE APPLICATION FORM:

The Applicants have to read the User Guide for Online Submission of Applications and then Proceed further.

I Step:- Payment of Fee: The Applicant should pay the prescribed Fee as per the notification in any one of the A.P. Online centers and obtain Fee paid receipt with Journal Number _____ digit in the first instance. Applicants can also pay the fee through AP Online portal.

II Step:- Submission of Application: After payment of Fees, the Candidate has to logon to the

Website <http://apspdcl.cgg.gov.in> and click on **Apply Online** link to view the detailed notification, User Guide and Application Form. The Applicants have to provide payment details (Journal number and date) and upload the scanned copy of passport size photograph with signature (see instructions for scanning and uploading photograph with signature) and then invariably fill all the relevant fields in the Application. Immediately on Submission of application, applicant will get an acknowledgement in the form of a downloadable PDF document.

NOTE:

1. The Applicants are required to go through the detailed notification and decide themselves as to their eligibility for this recruitment carefully before applying and enter the particulars completely online.
2. Candidates are required to retain a photocopy of application form with Reference ID for future reference.
3. Candidates have to submit application only through online mode well in advance of the last date to avoid last day rush.

6. APSPDCL is not responsible, for any discrepancy in submitting through Online. The applicants are therefore, advised to strictly follow the instructions and User guide in their own interest.
7. Applicant must compulsorily fill-up all relevant fields of application and submit application through website only.
8. Incomplete / incorrect application form will be summarily rejected. APSPDCL under any circumstances will not entertain the information if any furnished by the candidate subsequently. Applicants should be careful in filling-up of the application form at the time of Submission. If any lapse is detected during the scrutiny, his/her candidature will be rejected even though he/she comes through the final stage of recruitment process or even at a later stage.
9. Before payment of fee and submission of application form, the candidates should carefully ensure his/her eligibility for the post of Assistant Engineer/El as per the terms & conditions of notification. No relevant column of the application form should be left blank; otherwise application form will not be accepted. Fee once paid will not be refunded at any cost.

10. The applications received online in the prescribed proforma available in the website and within the time shall only be considered and the APSPDCL will not be held responsible for any kind of discrepancy.
11. Applicants must compulsorily upload his/her own scanned photo with signature in JPG format only.

General Conditions:

- The Candidate should not furnish any false tampered, fabricated information or suppress any material information while filling up the application form.
- Candidates will be required to furnish documentary proof in evidence of the following as and when called for to verification of original certificates.
 - a) Age: Proof of age as recorded in SSC certificate or equivalent
 - b) Degree certificates B.E/B.TECH/A.M.I.E. in Electrical & Electronics Engineering or equivalent qualification in the similar discipline from any recognized University in India.
 - c) Permanent Community certificate issued by MRO in original or Original caste certificate issued by Revenue Officer not less than the rank of MRO issued six months latest to the date of notification in respect of SC/ST & BC candidates clearly indicating the Sub-Caste and group.
 - d) Physically Handicapped certificate indicating the minimum 40% of disability issued by District Medical Board.
 - e) Study Certificate from IV to X Class.
 - f) Residential Certificate issued by the Officer of the Revenue Department not below the rank of Tahsildar in independent charge of Mandal as the case may be (In respect of candidates who have not studied in any Educational Institutions up to SSC).
 - g) Latest Passport size Photo.
- Candidates will be required to appear for written test as and when conducted at their own cost.
- Admission for written test or calling the qualified candidates in the written test to furnish documentary proof does not confer any right for appointment.
- The decision of the Selection Committee/APSPDCL is final in selection and allotment of candidates.

- Disqualification:- Conviction in Criminal Cases involving moral turpitude or declared insolvent.
- Medical fitness certificate should be furnished at the time of joining.
- The APSPDCL shall have right to cancellation/modification of notification at any time.

APTRANSCO in the references 1st & 2nd cited, issued comprehensive orders regarding recognition of Degrees/Diplomas awarded by Universities/Deemed Universities/Institutions through Regular / Part time / Distance Education Modes for considering Recruitment, Promotions, Incentive Increments & other service benefits.

In the letter 5th cited, the Principal Secretary Energy (Ser) Department, enclosed the letters received from the A.P. State Higher Education Council & observations made by the Higher Education Department regarding recognition of Degrees/Diplomas awarded by Deemed to be Universities to the courses offered through Distance mode and requested to take necessary action accordingly.

APTRANSCO in the reference 6th cited has issued orders to discontinue sanction of increments for possessing/acquiring higher qualifications, pending cases for which No Objection Certificates have been issued but so far sanction was not sanctioned.

Transmission Corporation of Andhra Pradesh Limited after careful consideration of the matter issues the following further orders:

Institute of Advanced Studies in Education (IASE), Rajasthan is a deemed to be university recognized by University Grants Commission under section 3 of UGC Act, 1956. The Deemed to be Universities run their academic programs defined under section 22 of UGC Act through class room teaching mode only.

UGC has not given approval to any deemed to be University either for starting their academic programs through distance mode or to run study centers in various parts of the country for this purpose UGC vide notice F.6-9/2001 (CPP.1) dt.23rd August, 2005.

UGC has not approved the conditional ex-post facto approval given by the Distance Education Council to the said Universities for their academic programs offered through Distance Education mode upto the year 2005 for which the approval of the UGC is mandatory.

The UGC vide Lr.No.f.6-25/2001 (CPP.1) has clearly stated that the UGC regrets its inability to grant ex-post facto approval for study centers run under distance mode offering various courses by IASE and directed to close down their study centers immediately.

As per the Notification F.No.DEC/Website dt.5-01-2006, the DEC clarified that the State Universities/Deemed to be Universities are not permitted to offer distance education outside the State of their location and Private study centers/franchising are not permissible.

-) As per the Gazette notification No.44, dated 01-03-1995 of Government of India, Degree/Diploma not recognized by DEC will not be considered eligible for Government services.
- i) For the courses run under distance mode, the approval of UGC-AICTE-DEC Joint Committee and letter of course wise approval under the signature of members of Joint Committee is required and this has not been issued by DEC.
- ii) UGC in its Notification, cautioned the students and advised not to take admission in the unapproved Off-Campus/Off-Shore Campus(s)/Study Centers/Colleges affiliated to Deemed Universities and courses run under distance mode (without the approval of UGC-AICTE-DEC Joint Committee). Study centers established by Deemed Universities are only for the purpose of advising, counseling and no student should be admitted in these centers.
- x) In case of Professional courses like Engineering, AICTE is repeatedly issuing public notices cautioning the students stating that it has been the policy of the AICTE, not to recognize the qualifications acquired through distance education mode at Diploma, Bachelors & Masters level in the fields of Engineering, Technology, Architecture, Town Planning, Pharmacy, Hotel Management & Catering technology are not recognized and the qualification acquired through distance mode may not be recognized for the purpose of employment under Central Government or for any other purpose vide Advt. No. UB/ 04(01)/ 2011 of AICTE.
- c) The above rule is applicable to all Universities including Deemed to be Universities like IASE, Rajasthan.
- ci) The UGC, which is an appropriate and authorized body, has not recognized the Distance Education Programs and study centers of the Deemed to be Universities.
- xii) The Degrees awarded by the Deemed to be Universities including IASE, Rajasthan for the programs offered under Distance Education mode through study centers located in A.P are not recognized. It is also clarified that the AICTE itself stated that its approval is mandatory for professions programs and UGC for general education programs. AICTE has not granted approval to any University to run Engineering Course under Distance Mode.

All the Functional Heads are requested to take necessary action accordingly.
